MAINE HARNESS RACING COMMISSION Chapter 9, Section 2, subsection 1 requires 'In order for its get to be eligible to the Maine Standardbred Breeders Stakes a stallion must be registered with the Commission prior to January 1 of the year of the breeding season and must stand at stud the full breeding season in Maine'. The breeding season is defined as the period beginning February 15 through July 15 of each calendar year. Registration fee will be \$100.00 per stallion per breeding season. Registration fees shall be made payable to the Treasurer, State Of Maine and forwarded to the Department's office and such fees will be added to the purses. **I AGREE TO PROVIDE A COPY OF THE BREEDING REPORT FILED WITH THE USTA TO THE COMMISSION NO LATER THAN SEPTEMBER 1 OF THIS BREEDING YEAR.**

Any person standing a stallion who fails to register a stallion as required aforesaid may register said stallion upon payment of the registration fee and an additional payment of \$500.00, on or before February 15 of that breeding season, providing the stallion has not been registered nor stood in any other jurisdiction.
